RE: 2023 UBA Playoff Structure & Prize Fund voting

UBA 2022-23 PLAYOFF INFORMATION

Due to the ever-changing landscape of the Underground Bowling Association and its districts, the organization has decided to shift the playoff structure from years past. The field moving forward will be a strict 64 team bracket, with each Conference getting an even 16 bids to the tournament. The breakdown is as follows:

Atlantic Conference (5 districts)

Top 2 teams from each district will advance. (10 teams)
The next highest 6 teams based on overall points will also advance.

All American Conference (3 districts)

Top 4 teams from each district will advance. (12 teams)
The next highest 4 teams based on overall points will also advance.

Northeast Conference (6 districts)

Top 2 each from each district will advance (12 teams)
The next highest 4 teams based on overall points will also advance.

Southeast Conference (6 districts)

Top 2 each from each district will advance (12 teams)
The next highest 4 teams based on overall points will also advance.

8 teams, (2 from each Conference) will advance to Battle Bowl.

The organization has also decided to shift the playoff payout structure to better represent the tournament itself. While there is no entry fee for the playoffs, all eliminating teams **WILL BE RESPONSIBLE for the lineage cost for their eliminated match which is \$202.50 (54 games @ \$3.75 per).**

UBA Playoff earnings will require a team to make it to their conference final 4. There will be no payouts until this round, meaning your team must win 2 matches to cash (*1:4 Payout Ratio*).

Each UBA Franchise will be voting on the playoff prize fund below. All members will be receiving an email on the voting instructions but votes will only be accepted by a Franchise Owner, President, or authorized team representative.

The Executive Office will be asking Owners, Presidents or team representatives to vote on the Season Tour & Playoff Prize Funds for the 2022-23 season. The voting form will be available on the UBATV website (www.ubatv.tv) under Forms & Documents on Monday December 12th 2022. You must be logged into your UBA Account to see it. Voting will commence on Monday, December 12th at 9am and end on Sunday, December 18th at 11:59pm. Each franchise is only allowed one vote and the UBA will accept the first vote submitted by each team. We will only accept votes from Team Owners, Presidents, Officers, or authorized representatives.

ALL FRANCHISE FEES FOR 2023-24 SEASON WILL BE DEDUCTED FROM EACH FRANCHISE'S SEASON TOUR WINNINGS AT THE END OF THE SEASON UNLESS THE TEAM OPTS OUT OF THE 2023-24 SEASON TOUR.

UBA Staff who own Franchises will not be allowed to vote, the team President or authorized representative must vote for team.
